REVIIEW & MONITORING

- 1. Progress of the projects undertaken shall be reviewed on quarterly basis by the review team Supervisor nominated by GENUS, Director(Academics), Director(D&W), Advisor (T&P), Dean (R&D) with Dean (R&D) as member secy
- 2. -IPR of the technology thus developed shall remain with Techno incubation centre at SKIT shall be governed by SKIT & GENUS.
- TECHNO INCUBATION CENTRE
 - Techno incubation centre at SKIT is already functional with 3 start ups working on smart grid
- 4. -SKIT has further plans to apply for ATAL incubation centre to get Governments grants/approval where collaboration with GENUS shall play an important role,
- -Technology thus developed shall be commercially exploited first by GENUS & right of refusal shall remain with them, otherwise technology shall be transferred to third parties on mutually
- 6. -However GENUS shall pay only royalty fees while other parties shall pay lump sum plus royalty which shall be shared both by GENUS/SKIT & development team members.

1.Confidentiality / Secrecy

SKIT and its students, its employees and anyone acting under it for the purpose of this MOU shall maintain strict confidentiality of the information belonging to Genus that may have come into its / their possession or knowledge because of the collaboration activities under this MOU. Such information shall not be divested or disclosed to any other third party under any circumstances, whatsoever, without obtaining prior written approval from Genus.

"Confidential Information" in this MOU shall mean confidential information and proprietary information concerning Genus including and without limitation; trade secrets, secret information, technical processes, finances, software language codes, any research material, text, dealings and method of dealings with the clients or the customers and its employees together with similar information of confidential or proprietary nature relating to Genus's suppliers, employees, agents, distributors, and customers and relationships of special trust and confidence with the clients or customers and employees.

SKIT may be exposed to Genus or any of its associate company's Confidential Information. SKIT agrees that, during and after the term of this MOU, it shall use the Confidential Information solely for purposes of performing its obligations and/or exercising its rights under this MOU, and shall not disclose to any third party any Confidential Information without the prior written consent of Genus. SKIT may disclose the Confidential Information only to its personnel / employees, students as is reasonably necessary to allow SKIT to perform its obligations under this MOU and to obtain the benefits thereof, provided that

The relationship of the parties under this MOU shall be nonexclusive and both Parties, including their affiliates, subsidiaries and divisions are free to pursue other collaborations of any kind.

3. Term & Termination

This MOU shall be effective from the date of signing and for a period of two years. This Agreement may be terminated by either Party upon fifteen (15) days prior written intimation.

4. Costs and Expenses

Each Party hereto shall be responsible for its own respective costs, risk and expenses involved in this MOU.

5. Assignment

This MOU is not assignable or transferable by either Party without the written consent of the other Party.
