SN	Mandatory conditions abiding to the Institute

4	As being a registered Society/Trust, the periodical elections for various posts enunciated in the constitution therein must be ensured with transparency and its proceedings shall be sent to university.			
5	In accordance with provisions under Statute-26(2) of Rajasthan Technical University, Kota Act, 2006 University representative shall be nominated in its governing body. Proceedings of all such meetings should be held in his presence.			

The awarded 5 years EOAA shall be valid subject to the following conditions:

7. The institute has to submit affiliation form and prescribed fee (Affiliation and Inspection fee) every year as per University's affiliation regulation and affiliation fee rule.

Institute shall maintain it's QIV ≥ 600 throughout 5 years of EOAA.

9. University shall revise the period of EOAA to 3 years / year wise as per the verification of QIV on the basis of the affiliation details submitted by the institute from the respective academic session. University may carry out the inspection, as per the requirement, for the verification of QIV.

11. The EOAA shall be amended as per the approved Engg. course with their intake, for the Engineering program as per the Extension of Approval (EOA) of AICTE for the respective academic session.

2. The EOAA will be immediately withdrawn on the closure of Engineering program/institute by AICTE and also on the non submission of AICTE Extension of Approval (EOA) before the expiry of the granted one time EOAA.
