## About IPTSE (Intellectual Property Talent Search Examination):

Launched in July 2018, Intellectual Property Talent Search Examination (IPTSE) is a proctored competitive examination that tests the knowledge of individuals on their understanding on various subjects of IP such as trademarks, geographical indications, trade secrets, copyrights, designs, patents etc. It is a first of its kind IP Olympiad that has thus far certified thousands of individuals. The examination is open for school students, Swami Keshvanand Institute of Technology students, faculties, working professionals and start-ups. It has various domains under which college students can register such as law/design & architecture/research & sciences/management & hospitality etc. An Annual award ceremony is organized where winners in various categories are awarded. 


