It is committed to build a culture of safety on roads through Capacity building, Training, Advocacy, Education Awareness and Campaigns & events. Its FCRA registration no is 125410051

This document is an agreement between Muskaan: foundation for Road Safety and Swami Keshvanand Institute of Technology, Management & Gramothan, for undertaking following Interventions:

- 1. Formation of Road Safety Club in college.
- 2. Organising Road Safety Orientation for Students and Faculty.
- 3. Organising Two- Wheeler riding training for Students and faculty.
- Collaboration for conducting awareness activities for community like rally, on road Campaign, theatre and other IEC activities. Attending Post Accident Care training programs being conducted for Police and Community.
- 5. To collaborate for research projects and related trainings to road accidents analysis and black spots.
- 6. Developing modules for capacity building of stakeholders departments like Road owning agencies, Police and Transport Department.

Objective:

Roles and Responsibilities

- College will arrange for participants and venue for training programs and other activities
- All the participants will get certificates for the activities they will participate in.
- Training participants will get reading material like pamphlets and booklets.
- During community activity like rally and on road campaigns, Muskaan will provide display material / placards.
- All the activities will be conducted in active collaboration of stakeholder departments.

Confidentially / Secrecy / Intellectual Property

Confidential information in this MoU shall mean confidential information and proprietary information concerning SKIT and MUSKAAN including and without limitation; trade secrets, secret information, technical processes, finances, software language codes, any research material, text, dealings and method of dealing with the clients or the customers and its employees together with similar information of confidential or proprietary nature relating to SKIT and MUSKAAN suppliers, employees, agents, distributors and customers and relationships of special trust and confidence with the clients or customers and employees, Each Party and its students, its employees and anyone acting under it for the purpose of this MoU shall maintain strict confidentiality of the information belonging to the other party that may have come into its / their possession of knowledge because of the collaboration activities under this MoU. Such information shall not be divested or disclosed to any other third party under any circumstances, whatsoever, without obtaining prior written approval from the other party.

The SKIT may be exposed to MUSKAAN or any of its associate company's Confidential Information. The SKIT agrees that during and after the term of this MoU, it shall use the confidential Information solely for purposes of performing its obligations and / or exercising its rights under this MoU and shall not disclose to any third party any Confidential Information without the prior written consent of MUSKAAN. The SKIT may disclose the Confidential Information only to its personnel / employees, students as is reasonably necessary to allow the Institute to perform its obligations under this MoU and to obtain the benefits thereof. The Institute will ensure full security of MUSKAAN'S data and documents.

All the actual data of MUSKAAN in form of documents and database (either soft or hard copies) with the SKIT will be discarded upon expiry or early termination of this MoU.

Both the parties shall not use the Confidential Information to procure a commercial advantage over each other.

Intellectual Property generated under the operation of MoU, if any shall be joint property of both the Parties in equal share. All obligations respecting the Confidential Information already provided hereunder shall survive any termination of this MoU.

Terms and Termination

This MOU shall be effective from the date of singing and will remain on force till either of the party terminates it with a written notice of one month without affecting the ongoing activities in any way.

Cost and Expense

Each party hereto shall be responsible for its own respective cost, risk and expense involved in MOU and shall not held liable to the other party in any manner or for any consequences of this MOU

Non- Exclusivity

The relationship of the parties under this MoU shall be nonexclusive and both parties including their affiliates, subsidiaries and divisions are free to pursue other collaborations of any kind

Assignment

This MOU is not assignable or transferable by either Party without the written consent of the other party.

If any dispute or disagreement arises during the operations of MoU, the same will be amicably resolved by mutual discussion between the respective Heads of both the Parties.

REPORT



The Three Days Capacity Building Program on "Road Safety Management: Basics of Traffic Engineering & Enforcement" for Police personnel of Uttarakhand Police Department was conducted under the collaboration of Muskaan: Foundation for Road Safety and Centre for Transportation Engineering (A Centre of Excellence), Swami Keshvanand Institute of Technology, Management & Gramothan, Jaipur.

The workshop was conducted for the Police personnel various cities of Uttarakhand from 2nd to 4th April 2024. The officers were provided the training on the importance of authentic data of an accident which in turn facilitate the designing of policy-level interventions for the reduction of road traffic accidents.

Thirty participants from various Police stations participated in the workshop.



On day first of the workshop the trainers took detailed sessions on Road Safety Management using several case studies and presentations. United Nations 5 pillars of road safety, Traffic Engineering & relation with Road Safety, Data Collection & Management, Motor Vehicle Driving Regulations 2017, Traffic Calmning Measures, Road Signs and Markings, Crash Investigation & data recordings along with Education Awareness modules were discussed in detail.



On day second of the workshop, the participants were taken to field investigation in small groups of four to five. The groups investigated the site with the view of probable causes of accident at the site. The major identification on the site were the wrong side movement of people, lack of pedestrian facilities, improper markings and signages. Moreover inadequate lightning facilities were also found at the site.



On Day three, the participants presented their study by explaining the findings and their recommendations. The group identified various issues and based on the previous day learning they were able to suggest and recommend the rectifications for the same.

At the end the certificates were distributed to all participants. Many senior police officials were present during the valedictory ceremony.



The master trainers Ms. Neha Khullar (Director Projects – Muskaan), Mr. Anirudh Mathur (Coordinator – Centre for Trans. Engg, SKIT) and Mr. Rajesh Meena (Muskaan) trained the participants about the various factors leading to accident and the relevant clauses in Motor Vehicle Act and Regulations.
