Day 1 21 February 2024 The programme proceeded with the first session by CA

Kuldeep Gupta on Sources of Income (Salaried, Professional, Shares, Interest. Sessions on sources of income often aim to educate individuals on how to diversify their income streams, maximize earning potential, and achieve financial stability. Understanding the various sources of income available can help individuals make informed decisions about their financial planning, investment strategies, and overall wealth management.

On day 2, 22 February 2024 the session was taken by CA Naveen Gupta on "Investment opportunities & awareness." In this session, participants likely learned about various investment avenues, strategies, and the importance of being aware of different investment opportunities.
