Agenda: A written complaint received from a girl student about a group of boys who were playing cheap songs while on college educational trip.

Resolution: After making an investigation about girl's complaint made against the boys for playing cheap songs, the cell observed that actions and lyrics of the song were not appropriate. The cell along with Head-OSA and Chief Proctor took the statements of faculty members and students who were accompanying these students on the college trip and found a group of students guilty for their behaviour. The cell addressed it by calling a meeting of boys and their parents in the office of OSA and warned the boys strictly not to continue this practice and sought written apology from them. Also the boys, who were performing cheap actions on the song during the trip, were suspended from the college for a week with a warning not to repeat this behaviour in future.
