

Feedback Analysis of Faculty Responses-2021-22:- Remarks

- 1. The institute faculty members show positive gratitude towards the overall working culture of the institute. It is very supportive, cooperative and encouraging toward research and publication and also provides financial support for it.
- 2. Most of the faculty members have admitted that they are well aware of the institutional policies and their governance.
- 3. The administration is very supportive and encouraging toward the knowledge enhancement, research and publication and they also provide financial support (MOOCs, Membership, publication etc.) for it.
- **4.** Most faculty members agreed and gave a positive opinion for Students' response towards the studies but some destruction occurred due to COVID pandemic.
- 5. Students are satisfied with elective subjects as their choice is considered.
- **6.** It is observed from an opinion poll that faculties are satisfied with their subject choice because departments emphasize on their research area to be same to the subject domain which they choose.
- 7. The faculty members have admitted that the Institute gives flexibility to adapt any tool, technique and teaching methodologies to teach students such as PPTs, Smart board, E-studio, group discussion, participation etc.
- **8.** Most of the faculty members and students have admitted that they are well aware of course objectives of the syllabi and are well defined and clear.
- 9. Maximum faculty gives average opinion about Course objectives of the syllabi which are well defined and clear to all teachers and students.
- **10.** The average opinion about the course is that it has a good balance between theory and practical applications.
- **11.** The faculties strongly agreed on the ample amount of relevant and updated reference books/E-journals etc. available in the central library.
- **12.** The working environment in the department is conducive to teaching and encourages research publication and faculty development.
