3. University shall revise the period of EOAA to 3 years / year wise as per the verification of QIV on the basis of the affiliation details submitted by the institute from the respective academic session. University may carry out the inspection, as per the requirement, for the verification of QIV.
4. One time EOAA granted to the institute shall be revised / withdrawn on the verification of the non fulfillment of any mandatory requirements as laid down by AICTE/COA/RTU. The same will also be applicable on the verification of any serious complaint against the institute.
5. The EOAA shall be amended as per the approved course(s), with their intakes, for the engineering program as per the Extension of Approval (EOA) of AICTE for the respective academic session.



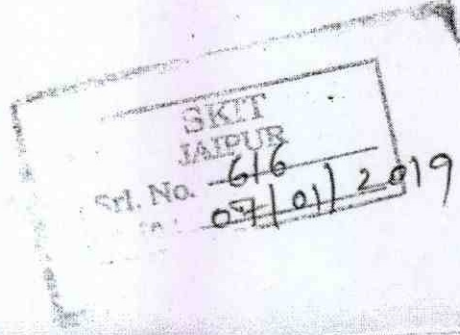
