
AC.Spl. 24.4 To consider the B. Tech. Regulation for Choice Based Credit System (CBCS) for University Departments

Committee has submitted the report of B.Tech. Regulation for Choice based credit system for University Departments for consideration and approval.

The Minutes 23rd Academic Council has been put in the 26th BoM held on 11.4.2017 for consideration of Hon'ble members at agenda item no 26.5. As per directions of BoM it was resolved that committee will submit the draft regulation (Choice Based Credit System) & framework of teaching scheme for B.Tech

Courses of University teaching department. The committee submitted draft regulation (Choice Based Credit System) & framework of teaching scheme for B.Tech Courses of University teaching department for perusal and consideration. (

Resolution: The proposed draft will be amended as per suggestions received. Committee will submit amended draft latest by 25th July 2017 to Hon'ble Vice Chancellor after incorporating suggestions.

The draft M.Tech ordinances & Regulations for all the affiliated colleges of the Rajasthan Technical University for Smooth functioning of M.Tech. Courses run by University is submitted for perusal and approval.

Resolution: Draft M. Tech Ordinances and regulations will be amended by the committee by 31st July 2017 and the same will be submitted before faculty by 10th August 2017 for final approval in next Academic Council.

AC.Spl. 24.6 To Consider the minutes of Faculty of Engineering and Architecture dated 7.07.2017 & minutes of Faculty of Computer Application dated 25.5.2017

The minutes of Faculty of Engineering and Architecture dated 7-07-2017 regarding new scheme and syllabus of B.Tech. & minutes of Faculty of Computer Application dated 25.5.2017 is submitted for consideration.

Resolution: Minutes of the 20th FOEA were approved except the syllabus of computer programming code No. CS 101, CS 102, CS 103 & CS 104. A committee constituted by HVC will submit revised syllabus of above subject by 25th July 2017 to HVC.

Minutes of 7th Meeting of Faculty of Computer Applications (FOCA) dated 27.05.2017 are also approved.

AC.Spl. 24.7 To consider the mercy chance to the students of B.Tech, BHMCT, B. Arch., MCA and MBA who have not completed their degree even after completion of double the duration of prescribed course time.

Presently, the students of B.Tech. 2006 to 2008 (LEEP 2007 to 2009), BHMCT 2006 to 2008, MCA 2006 to 2010 and MBA 2006 to 2012 admitted batches were given mercy chance to complete their degree as per directions of Raj Bhawan and Academic Council, who could not pass all papers (copies of orders/minutes are enclosed).

As per University rules a student admitted in B.Tech, BHMCT, B.Arch., MCA and MBA course is required to complete his/her course/degree in 8, 8, 10, 6 and 4 years duration respectively i.e. double the duration prescribed for the course.

Now, many applications are received from students of afterwards batches, who could not completed their course as still one or more papers are due to complete their degree as per requirement .

In view of the above and in the interest of student, decision for granting of a Mercy chance to the students of B.Tech. 2009 (LEEP 2010), BHMCT 2009, B.Arch. 2007, MCA 2011 and MBA 2013 admitted batches who have not completed their degree even after completion of double the duration of prescribed course time, in academic session 2017-18 may be taken.

Resolution Proposal is approved.

AC.Spl. 24.8 To consider and approve the award of division in various courses run by the University viz. B.Tech., B.Arch. BHMCT, MBA, MCA, M.Tech. & M.Arch.

Presently, division is awarded after completion of course by a candidate for B.Tech., B.Arch., BHMCT, MBA, MCA, M. Tech. & M.Arch. programme. Provisions of the following ordinances and rules for calculation of division are followed:

- A. Ordinance 300-A (Rule 34-A) for B.Tech. Programme.
- B. Ordinance 300-B (Rule 34-B) for B.Arch. Programme.
- C. Ordinance 319-Q for M.Tech. Programme.
- D. Schemes and rules framed by the BOS concern for BHMCT, MCA, MBA and M.Arch. course.

Copy of the same are attached herewith for kind perusal of members.

In the provisions of two courses viz. BHMCT and MBA, it is provided that "If a candidate passes all examination in first attempt without grace and secure 70% or more marks, he/she shall be placed in First Division with Honours" Provisions of rest other courses are not having such rider.

Presently, RTU is awarding Honours degree to all such candidates who secures 70% or more marks for all such courses.

On account of following these provisions, it is observed that many candidates have secured Honours degree which still have cleared their paper with many backlogs attempt, Grace Marks and even after availing mercy chances.

In order to have a uniform policy for awarding division, it is proposed that for all courses being run by University, following rule of award of degree may be considered for 2017-18 and onward admitted batches :

1. First Division with Honours:

- (a) For MBA course - If a candidate passes all examination in first attempt without grace and secures 75% or more marks.

- (b) For other courses - If a candidate passes all examination in first attempt without grace and secures 70% or more marks.
2. **First Division** : 60% marks or above in the aggregate of the course.
 3. **Second Division** : 50% marks or above in the aggregate but below 60% marks of the course.
 4. **Pass Class** : Below 50% marks in the aggregate of the course. Provided the candidate has secured the minimum pass marks as specified under the relevant clause of individual course passing scheme.




