1. The appointment is in the AICTE pay band of Rs. 15,600 – 39,100. Your initial pay will be (Basic Rs. 18,200 + AGP (Academic Grade Pay) Rs. 6,000) + DA (Dearness Allowance) 60% of Basic and AGP = Total Salary Rs. 38,720/- per month.
2. The appointment is initially on probation for a period of one year from the date of joining which can be extended provided your services are found satisfactory.
3. That during the probation period, your services can be dispensed with, without notice and without assigning any reason.
4. After satisfactory completion of probation period you will get provident fund @ 12% on basic pay of Rs. 15,000/- or actual, whichever is less.
