- 2.9 In case of any financial consideration to take up any program mentioned in the MOU, it will be dealt separately.


- 3. VALIDITY


This Agreement will be valid until it is expressly terminated by either Party or mutually agreed terms. Both Parties may terminate this NOU upon 30 calendar days
