This Memorandum of Understanding (MoU) is made between

The **Swami Keshvanand Institute of Technology, Management & Gramothan, Jaipur-302017, India** is an Institute affiliated to Rajasthan Technical University, Kota, India and recognized by All India Council for Technical Education (AICTE), having its office at Jaipur, hereinafter called SKIT;

and

National Institute of Technology, Uttarakhand, a national Institute of Technology, under Under the National Institute of Technology Act 2007(Government of India, Ministry of HRD), hereinafter called NIT, Uttarakhand.

In order to promote cooperation and the advancement of academic, research, and educational exchanges between SKIT and NIT, Uttarakhand the two institutions agree to formalise a MoU for **International Conference on New and Renewable Energy resources for Sustainable Future (ICONRER-2019) Nov. 7-9, 2019**, follows:

Within fields that are mutually acceptable, the following general forms of cooperation will be pursued:

- Guest Lectures/Plenary talks: Talks by Professors of NIT and SKIT in conferences and/or helping in arrangements of speakers in conference
- Technical Support in planning of conference: Helping in designing of conference themes and schedule.
- Participation in Conference: Faculty and students' participation in conferences and research papers at SKIT.

The purpose of this MoU is to express the intentions of the Parties, specifically for the mutual help of above said and future conferences. The terms of cooperation for specific activities contemplated under this MoU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity. Any such activities agreed upon will be recorded and governed by a separate document executed by both parties.

Activities to be organised under this agreement will be the responsibility of the Heads of both institutions or of persons undersigned. National regulations and customs shall be mutually respected.
